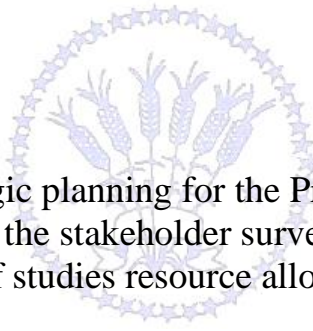

**NON-AGENDA ITEMS:**

1. SSSF's Full Circle America program has now reached a total of 78 members since inception, with several new members awaiting assessment and installation of equipment. Currently there are 34 members on the program. With more recent referrals, our average age has declined from 89 to 82, which in fact will help us meet our goal of starting people on the program earlier and keeping them at home and out of costly facilities for a longer time period of time. We are installing Elli-Q interactive devices in homes as well, and now have three members with this technology. Another is scheduled for late February.
2. Planning for SSSF's Bubbly and Brunch is underway at the newly air-conditioned Pleasant Valley Winery and Visitor's Center on July 30th. Brunch will be catered by Timber Stone Grill.
3. Our EISEP Home Care waiting list is currently at 124. Our county aides are serving 10 clients as well as providing an occasional back up plan if our contracted agencies cannot fill a case. The demand for home care is growing, as predicted.



4. The work of strategic planning for the ProAction Senior Nutrition continues although the stakeholder survey has been paused while administration staff studies resource allocations and cost of service delivery.
